VENDOIT WEBSITE PRIVACY POLICY

At **VENDOIT** we recognize that privacy is important. This Policy applies to all of the products and services offered by **Vendoit** Corporation (collectively, **Vendoit** 's "services"). **Information We Collect & How We Use It -** We offer a number of services that may not require you to register for an account or provide any personal information to us. However, in order to provide our full range of services, we may collect the following types of information.

Information You Provide - When you sign up for a **Vendoit** account or other **Vendoit** services that requires registration, we ask you for personal information (such as your name, email address and an account password). For certain services, such as our advertising programs, we also request credit card or other payment account information which we maintain in encrypted form on secure servers. All such information will be used only for the purposes for which it was provided.

Vendoit Cookies - When you visit **Vendoit**, we send one or more cookies - a small file containing a string of characters - to your computer that uniquely identifies your browser. We use cookies to improve the quality of our service by storing user preferences and tracking user trends, such as how people search. Most browsers are initially set up to accept cookies, but you can reset your browser to refuse all cookies or to indicate when a cookie is being sent. However, some **Vendoit** features and services may not function properly if your cookies are disabled.

Log Information - When you use **Vendoit**'s services, our servers automatically record information that your browser sends whenever you visit a website. These server logs may include information such as your web request, Internet Protocol address, browser type, browser language, the date and time of your request, referring/exit pages and URLs, platform type, number of clicks, domain names, landing pages, pages viewed and the order of those pages, the amount of time spent on particular pages and one or more cookies that may uniquely identify your browser. **Vendoit** uses software that receives and records the Internet protocol IP addresses. **Vendoit** will not try to link these addresses with the identity of the individuals visiting its site except in cases of abuse of its site.

Clear Gifs Information- When you use our services, we may employ "clear gifs" (a.k.a. Web Beacons) which are used to track the online usage patterns of our Users anonymously (i.e., in a non-personally-identifiable manner). In addition, we may also use clear gifs in HTML-based emails sent to our users to track which emails are opened by recipients. User Communications - When you send email or other communication to Vendoit, we may retain those communications in order to process your inquiries, respond to your requests and improve our services.

Links - Vendoit may present links in a format that enables us to keep track of whether these links have been followed. We use this information to improve the quality of our search technology, customized content and advertising.

Other Sites - This Privacy Policy applies to web sites and services that are owned and operated by **Vendoit**. We do not exercise control over the sites displayed as links from within our various services. These other sites may place their own cookies or other files on your computer, collect data or solicit personal information from you.

Vendoit processes personal information on our servers in other jurisdictions such as the United States and Canada. We may process personal information to provide our ownservices. In some cases, we may process personal information on behalf of and according to the instructions of a third party, such as our advertising partners.

Choices For Personal Information - When you sign up for a service that requires registration, we ask you to provide personal information. If we propose to use personal information for any purposes other than those described in this Policy or in the specific service notices, we will offer you an effective way to opt out of the use of personal information for those other purposes. We will not collect or use personal information for purposes other than those described in this Policy or in the specific service notices, unless we have obtained your prior consent. You can decline to submit personal information to any of our services, in which case **Vendoit** may not be able to provide those services to you. **Vendoit** does not automatically gather any information from you. Information is only obtained if you supply it to us. Information provided to the Company is only used for the Company's internal purposes including contacting you and answering you queries.

Information Sharing - Vendoit only shares personal information with other companies or individuals outside of **Vendoit** in the following limited circumstances:

We have your consent. **Vendoit** will not sell the visitor information provided to it except in connection with the sale, merger or transfer of the Company's business or in connection with a sale of its shares. We will not give or sell the confidential information to any third-party marketer. We provide such information to our affiliated companies or other trusted businesses or persons for the purpose of processing personal information on our behalf. We require that these parties agree to process such information based on our instructions and in compliance with this Policy and any other appropriate confidentiality and security measures. We have a good faith belief that access, use, preservation or disclosure of such information is reasonably necessary to

- (a) satisfy any applicable law, regulation, legal process or enforceable governmental request,
- (b) enforce **Vendoit**'s Terms of Use including investigation of potential violations thereof,
- (c) detect, prevent, or otherwise address fraud, security or technical issues, or
- (d) protect against imminent harm to the rights, property or safety of Vendoit, its users or the public as required or permitted by law.

Information Security - We take appropriate security measures to protect against unauthorized access to or unauthorized alteration, disclosure or destruction of data. These include internal reviews of our data collection, storage and processing practices and security measures, as well as physical security measures to guard against unauthorized access to systems where we store personal data. We restrict access to personal information to Vendoit's employees, contractors and agents who need to know that information in order to operate, develop or improve our services. These individuals are bound by confidentiality obligations subject to enforcement, if they fail to meet these obligations. Visitor information is treated by Vendoit as confidential information. Visitor information will not be disclosed to anyone without consent except as required by law, or in accordance

with this privacy statement or as permitted pursuant to the Personal Information Protection and Electronic Documents Act (Ont.CDN)("*Pipeda*").

Data Integrity - Vendoit processes personal information only for the purposes for which it was collected and in accordance with this Policy or any applicable service-specific privacy notice. We review our data collection, storage and processing practices to ensurethat we only collect, store and process the personal information needed to provide or improve our services. We take reasonable steps to ensure that the personal information we process is accurate, complete, and current, but we depend on our users to update or correct their personal information whenever necessary.

Accessing & Updating Personal Information - When you use Vendoit's services, we make good faith efforts to provide you with access to your personal information, either to correct this data if it is inaccurate or to delete such data at your request if it is not otherwise required to be retained by law or for legitimate business purposes. Upon the request of any visitor who has provided information to **Vendoit** and upon provision of identification satisfactory to the Company identifying the requester as the person who supplied the information the Company will supply a copy of the information on its files about that person to that person for verification and correction provided that the supply of such information does not and will not affect or reveal any information which is confidential to any other party and provided that the supply by **Vendoit** of such information will not affect confidentiality with respect to which any matter **Vendoit** is entitled to maintain as confidential pursuant to *Pipeda*. We ask individual users to identify themselves and the information requested to be accessed, corrected or removed before processing such requests, and we may decline to process requests that are unreasonably repetitive or systematic, require disproportionate technical effort, jeopardize the privacy of others, or would be extremely impractical (for instance, requests concerning information residing on backup tapes), or for which access is not otherwise required. In any case where we provide information access and correction, we perform this service free of charge, except if doing so would require a disproportionate effort.
